Test your knowledge with the following questions (answers can be found later in this newsletter) -

- 1. The Chief Judge will take a 0.30 deduction for unauthorized or additional mats on Floor when:
- A. Two mats are placed in different corners on the Floor Exercise mat B. Two mats are placed end-to-end into one corner
- C. One mat is placed on the floor exercise area, overlying the floor boundary and the boundary lines are not marked

2. The Chief Judge takes the deduction for incorrect attire from the average score. Which of the following statements is correct? A. After a warning from the Chief Judge on the first event, the

deduction of 0.20 is take on each subsequent event if the attire issue is not corrected

B. The deduction of 0.20 is taken only one time, on the first event where the attire issue is identified

C. The deduction of 0.10 is taken only one time, on the first event where the attire issue is identified

D. The deduction of 0.20 is taken only one time, on the second event, after a warning from the Chief Judge on the first event

3. A Level 6-10 bar routine is considered as too short. Which of the following statements is correct?

A. The Chief Judge applies a deduction of 2.0 if the routines has less than 5 value parts

B. The Chief Judge applies a deduction of 1.0 if the routine has 4 or less value parts

C. If the routine is short due to a fall with injury and the gymnast cannot complete her routine, the Chief Judge does NOT take the dismount Special Requirement (SR#4) deduction in addition to the short routine deduction of 1.0

D. The 2.0 short routine deduction is NOT a Chief Judge deduction, it is calculated by all panel judges and taken from the score of each panel judge.

- If you are an affiliated judge, and you are listed as a head judge when event assignments are released, please let your meet referee and event assigner know immediately so that she may make the proper changes.
- If your CPE credits are not up to date, you may not be assigned to sanctioned meets. In an unusual circumstance where there is an absolute necessity to assign a judge who is delinquent in completing their CPE credits, the judges' compensation will be reduced by \$5.00 per hour. Please refer to pages 32 of the Rules and Policies for further information pertaining to CPE credits.
- Please let Marcy Blitz know if any of your information in the judges directory is incorrect so it can be corrected.
- If any of your information changes (i.e. rating, address, etc.) please notify NAWGJ, USAG and the SJD.
- Please do not wait until the last minute to renew your USAG membership, safety certification, safe sport and/or background check. If any of your dates are not current, you will not be allowed on the floor at a sanctioned meet.
- If you are on any medication, please keep a list of your medications in your purse in case of emergency. Also, be sure to carry on your medications if you are flying to any away meets.

IMPORTANT INFORMATION REGARDING MEETS NEXT SEASON

• In order to be assigned to any USAG or YMCA competition you must be a member of NAWGJ. If you are not a NAWGJ member you will not be assigned to future meets.

• To be eligible to judge USAICG sanctioned competitions you must attend a USAIGC Rules Clinic. These clinics are held in the fall and are free to attend. More information will be sent out as it becomes available. If you are currently eligible to judge USAIGC you do not need to attend a clinic this fall.

• To be eligible to judge a USAG Regional meet in 2020 you must attend Region 7 Congress or volunteer at a Region 7 training camp. This does not guarantee you a regional assignment, but does make you eligible.
