• If you are an affiliated judge, and you are listed as a head judge when event assignments are released, please let your meet referee and event assigner know immediately so that she may make the proper changes.

• If your CPE credits are not up to date, you may not be assigned to sanctioned meets. In an unusual circumstance where there is an absolute necessity to assign a judge who is delinquent in completing their CPE credits, the judges' compensation will be reduced by \$5.00 per hour. Please refer to pages 32 of the Rules and Policies for further information pertaining to CPE credits.

• Please let Marcy Blitz know if any of your information in the judges directory is incorrect so it can be corrected.

• If any of your information changes (i.e. rating, address, etc.) please notify NAWGJ, USAG and the SJD.

• Please do not wait until the last minute to renew your USAG membership, safety certification, safe sport and/or background check. If any of your dates are not current, you will not be allowed on the floor at a sanctioned meet.

• If you are on any medication, please keep a list of your medications in your purse in case of emergency. Also, be sure to carry on your medications if you are flying to any away meets.


If you know of anyone interested in judging, please encourage them to attend our New Judges Clinic! We can ALWAYS use more judges!
